#### **4. Oath of Office – Rachel Gokey – Village of Sand Lake**

The Oath of Office was administered to Rachel Gokey of Sand Lake. Rachel greeted the Council and said she looked forward to working with everyone.

#### **5. Communications Contract**

Mike DeVries and John Weiss explained the contract is coming before the Board after an extensive process that included an RFP, proposals and presentations. The Executive Committee reviewed the proposals based on predetermined criteria and ability to meet the needs of the Council. The Executive Committee recommends approval of the proposal from Truscott Rossman. Tim Dye was present to answer questions.

Questions were taken from those in attendance.

Steve Kepley stated he was uncomfortable working with Truscott Rossman as the firm had worked for the group supporting Proposition 1 and the information and talking points coming out of that campaign were different than what the opposition had heard from the MML, MTA, and groups from California and Colorado. He will be voting against awarding the contract to Truscott Rossman and would rather work with a firm that didn't have this burden.

Tim Dye explained that he didn't work on that issue, but if more information was needed, it could be obtained from Truscott Rossman.

Al Vanderberg stated Truscott Rossman is much like other multi-client firms that work for various local governments. It is hard to find a firm that has not at one time or another worked on an issue they opposed. Truscott Rossman worked with the local group who supported the PPT and was extremely successful. The Executive Committee went through an extensive process and recommends Truscott Rossman as the most qualified.

Wayman Britt stated he also has had very positive experiences working with Truscott Rossman (TR) on immigration issues and is impressed by the completeness and support they received. He has similar concerns with Proposal 1, but still support TR for this contract.

Karen McCarthy reported that Consumers Energy has worked with TR extensively for their communications strategy and they have been very helpful.

John Weiss explained the in-depth process undertaken. MDOT has also reviewed and approved the contract.

Mike DeVries added that the Executive Committee has had long discussions and was very deliberative in making this recommendation. Mayor Kepley had made his opposition known to the group, which was taken into consideration. The Executive Committee voted unanimously to recommend the contract.

#### Goal 1 - Training

##### Provide law enforcement officers with 40 hours of comprehensive crisis intervention training for individuals with mental illness

- In 2016, there were only 4 CIT trained officers in Kent County
- Currently, the KCCIT has trained:
  - ✓ 139 police officers from 18 different agencies including the United States Secret Service
  - ✓ 50 KCSD Corrections officers
  - ✓ 54 KCSD Emergency Communications Operators.
