## 4. Update on Usage of Service Hours

Paul Gerndt commented that many communities still have hours on the table. Jason Moore reviewed the table, which is updated weekly. He reminded the group that it is getting towards the end of the fiscal year (September 30<sup>th</sup>), and the service hours are use it or lose it. REGIS has already contacted members that have gone over their hours.

Jason reviewed the proposed service hour schedule for the next fiscal year (10/1/2022 – 9/30/2023). He reminded the group that the new 2020 census figures are in use and per the equity structure put in place in 2016, dues are based on the census population figures and the equalization reports. Service hours are then based upon the dues.

## 5. Project Spotlights

### a. **Gaines Township Master Plan Survey**

Steven Musch worked with Dan Wells to develop this survey to get more public participation in the Master Plan process. In addition to input through in-person meetings, citizens are able to give input online. Using current zoning maps, people are able to pin locations and indicate changes they would like to see. The system uses Survey 1-2-3 and includes descriptions of zoning types and uses. On the back end, this gives a lot of data to review and analyze. In the future, this type of project should be pretty easy to set up for other members.

Jonathan Seyferth said the public has expressed satisfaction in being able to participate online. This will also mitigate criticism of not reaching out to enough of the public. We are really thankful for the help.

Jason Moore added this can be applied to lots of different local government projects.

### b. **City of East Grand Rapids Water Service Material Inventory**

Jason Moore displayed the East Grand Rapids project to show visually lead vs other materials in their water system.

Doug LaFave stated they are working on enhancing distributor systems and transparency for the public. This system does that through both maps and spreadsheets.

Jason Moore stated it started in ArcMap and is visible on E-REGIS type of maps, so every user can zoom in and get a visual. It is a really good idea that others may want to add at some point. We are also able to cross reference it to PASER ratings. Please reach out to Jason if you are interested in this type of project for your community.

### c. **Fire Department Service Area Analysis (Dutton & Cuttlerville Fire Departments)**

This project updated the 2020 census figures for the Dutton / Cuttlerville Fire Department to analyze response times / drive times. We were able to create different layers including zoning, property classes, estimate population, etc. and create a map. The update of the population figures was difficult as the census boundaries don't follow the service area blocks.

Jonathan Seyferth said it was a really good project and thanked the staff for their help.

### d. **New Layers added to Theme Manager** **- The Rapid: Bus Stops & Routes**

**6. REGIS Data enter Software Upgrades – Progress Update**

**Overall Goal: Microsoft Server Operating Systems 2012R2 to 2019**

- a. Domain Controller and File Share Servers – **Completed November/December**
- b. Citrix – **Completed January 2022**
- c. ESRI Software – ArcMap 10.6 to ArcMap 10.81 – **Completed January 2022**

d. **\*\* Updated Mailing Label Tool**

We are working on an optional tool to remove vacant parcels, but it has to be used with caution. Hopefully this will help create mailing labels while weeding out vacant properties. The caution is, the tool is only as good as the data that goes into it. Accurate / current assessor data is crucial.

It is also possible to create another layer for vacant properties to cross reference.

e. **ESRI Software – ArcGIS Server 10.6.1 to ArcGIS Server 10.8.1 (in progress)**

We are building a new server parallel and migrating everything over with the help of consultants. The goal is for all of this to be seamless for users

f. **Microsoft SQL Server (in progress)**

Again, we are building a parallel server. It will affect the editing environment and Jason will communicate with everyone as needed. We are taking time to make sure it is done right.

**7. ArcMap User Directory (I) drive cleanup discussion**

Jing Han explained that there are currently 650 gigabytes on the ArcMap User directory (I) drive. Many of these files haven't been used since 2006. The user folder has many users who are not currently valid.

Paul Gerndt referred to record retention policies and is not sure how that applies to REGIS.

Travis Mabry asked what the danger is of keeping those files, as from an engineering point of view, he would like everything preserved indefinitely.

Jason Moore explained that the information would be archived, not deleted.

Paul Gerndt said there is no danger, but rather an economic impact and could affect time in a recovery scenario, making it take much longer.

It was agreed to discuss the topic in the Tech committee and develop a plan.
